The Company clarifies that it is not aware of any relevant undisclosed information that could justify the price and volume fluctuations in question. We reiterate that on 06/03/2022 a Material Fact was disclosed about the final and unappealable decision in favor of the Company in the lawsuit claiming exclusion from the levying of Corporate Income Tax and Social Contribution on Net Income on the portion corresponding to inflation of income from financial investments, however, the calculation has not yet been finished by our legal advisors, which will give rise to the disclosure of a new material fact.

The Company will maintain its shareholders and the market informed of any event that may significantly influence the price of its securities or investors' decision to buy, hold, sell or exercise any rights arising from their ownership of securities issued by the Company or otherwise referenced therein, pursuant to Articles 2 and 3 of CVM Instruction 44/21.
