NOTICE TO SHAREHOLDERS

Bento Gonçalves, RS, April 27, 2021 – Unicasa Indústria de Móveis S.A. (B3: UCAS3, Bloomberg: UCAS3:BZ, Reuters: UCAS3), one of Brazil's leading manufacturers of customized furniture and the only publicly-held Brazilian company in the sector ("Company"), hereby informs its shareholders that the Shareholders Meeting held today at 1:30 p.m. approved the Payment of Interest on Equity and Dividends as follows:

1. INTEREST ON EQUITY:

Seven million, ninety-seven thousand, six hundred seventy-five reais and forty-nine centavos (R\$7,097,675.49), corresponding to R\$ 0.107399990 per share as Interest on Equity, calculated towards mandatory dividends, pursuant to article 9, paragraph 7 of Law 9,249/95.

All common shareholders of record on December 04, 2020 will be entitled to interest on equity, with the shares trading ex-interest on equity as from December 07, 2020, inclusive, as resolved at the Board of Directors Meeting held on December 01, 2020.

2. DIVIDENDS

Six million, nine hundred ninety-three thousand, seven hundred sixty-four reais and sixty-three centavos (R\$6,993,764.63), corresponding to R\$ 0.105827650 per share will be paid as additional dividends.

All common shareholders of record on May 11, 2021 will be entitled to additional dividends, and shares will be traded ex-dividends on B3 S.A. - Brasil, Bolsa, Balcão starting from May 12, 2021, inclusive.

3. PAYMENT DATE

Both Interest on Equity and Dividends will be paid on May 28, 2021, without any interest or inflation adjustment.

4. INSTRUCTIONS ON PAYMENT OF DIVIDENDS

Shareholders will receive the dividends according to the information provided to Banco Bradesco S.A., the stock transfer agent of the Company, and those whose shares are held in custody at B3 will have their dividends transferred by their respective custody agents as from the payment date. For shareholders whose records are outdated and do not have the CPF/CNPJ number or the bank credit option, the amount will be credited to their bank account after they update their records at any branch of Banco Bradesco S.A.

5. INCOME TAX

The Interest on Equity will be subject to withholding income tax (IRRF) according to law.
